

Supporting Federal Border Security Efforts in Arizona

SB 1610 requires county detention facilities to provide personal identifying information and access to an arrested person, on the request of the U.S. Immigration and Customs Enforcement (ICE). I look forward to seeing these bills pass the House and advance to the Governor for her signature.

Andrew's Law: Cracking Down on Bullying

A bill designed to fight back against bullying in Arizona's K-12 schools is being considered in the House after passing the Senate with Republican support. "Andrew's Law," also known as SB 1508, was inspired by Andrew Harstad, a Hamilton High student who took his own life in 2022 after being relentlessly bullied at school. The bill requires a school district governing board to adopt specific definitions on bullying, cyberbullying, harassment, and intimidation. The definitions must be included within district policies and procedures to prohibit these detrimental behaviors within Arizona's schools, on school property, within school busses and at bus stops, at school-sponsored events, and through the use of technology or electronic communications. The bullying Andrew endured is becoming more common among our youth. In some cases, victims see no other options than to take their own lives to end the suffering. This crisis has only gotten worse with the evolution of cell phones and social media. It's time school districts adopt standardized policies with preventative measures and interventions to protect Arizona's youth. Clearly defining what bullying actually entails is a step in the right direction to ensure student safety, both on and off campus.








Protecting Children from Sexual Predators in Schools

I hosted a press conference this week calling on lawmakers and the Governor to support the passage of SB 1437 to protect children in Arizona's K-12 schools from sexual predators. Maricopa County Attorney Rachell Mitchell, child safety advocates, as well as a victim of sexual predation and her family, all joined in support. The bill adds governing board members of school districts and charter schools, substitute teachers, and school safety officers to the list of those who are required to report to a law enforcement agency any allegations of sexual misconduct of a public school employee with a student. After passing out of Senate Education Committee with unanimous bipartisan support, I was disheartened when the bill was brought to the Senate floor for a vote, and all Senate Democrats voted against it, despite nothing changing about the bill. SB 1437 has again received near unanimous bipartisan support in a House committee, so I'm hopeful that support will carry over when the bill is brought before the full House for a final vote.







Supporting Arizona Veterans Who Are Battling PTSD

Senate Republicans are supporting veterans by passing my legislation to provide funding for mental health services, and an emergency measure to allow transport and admission evaluations for veterans suffering with PTSD. Both bills are being transmitted to the House of Representatives for consideration after receiving bipartisan support in the Senate. SB 1162 is an emergency measure to give police officers, employed by the U.S. Department of Veterans Affairs, more opportunity to step in when a veteran is suffering from a mental SB 1710 establishes the Mental health crisis. Health Services for Veterans Grant Program. The bill appropriates \$2,000,000 from the state's general fund to the Arizona Department of Veterans' Services (ADVS) for the grant program. Increasing access to mental health services is a matter of life and death for many veterans. SB 1162 & SB 1710 will ensure veterans not only have access to the services they need when they are in the middle of a crisis but also have consistent and long-term support to address the mental health challenges they face before, during, and after combat. I'm hopeful that with bipartisan support, we can move forward in addressing these critical issues and ensure that every veteran gets the care they deserve.





Holding Pedophiles Accountable

During testimony last month in the Senate Committee on Judiciary, Pinal County Attorney Brad Miller revealed two undercover sting operations over a four-week period conducted by Pinal County Sheriff's Office earlier this year resulted in the arrest of 20 adults who were caught luring children for sex acts. Unfortunately, he reported some cases couldn't be charged under Dangerous Crimes Against Children statutes due to a court of appeals opinion on how current law is to be interpreted. I sponsored <u>SB</u> 1585 to make pedophiles lives hell, ensuring these monsters, who knowingly and intentionally target someone they believe to be a child, are held accountable under the full weight of our laws. Currently, some predators may only receive probation, instead of being thrown behind bars where they belong. Whether an undercover officer posing as a child catches the pervert for soliciting sex acts, or the victim is an actual child, both situations deserve serious consequences from our judicial system. SB 1585 passed out of the Senate unanimously.



Do No Harm: Patients' Bill of Rights Passes Senate

Senate Republicans are working to better protect patients who are receiving medical care in Arizona with a legislative proposal to bolster rights against unnecessary harm from healthcare providers. I am sponsoring SB 1600, which passed the Senate this week and heads to the House for consideration. The bill codifies a patient's rights into state statute. It stipulates that if a patient receives health care services in Arizona, the patient has the right to receive health care services from a health professional who acts only in the patient's best interest, resolves to do no harm to the patient, and ensures that each medical decision (except in an emergency) requires informed consent. In the wake of the pandemic, Arizonans are demanding peace of mind when receiving any form of health care from a licensed professional or provider. Government, corporations, and any other entities should not dictate what is best for a patient. These decisions need to be left up to the patient, in consultation with their doctors. By passing this proposal, our state is sending a clear message that we stand alongside patients making their own decisions for their respective avenues of health care.
