IMPORTANT PROPOSITIONS FROM THE LEGISLATURE We are just days away from a crucial election that will help determine the future of Arizona and our nation. Republicans at the Legislature spent tireless hours working to provide voters with the opportunity to have the final say on the key issues our state is facing. Despite Democrats voting 'no' on our proposals, we voted in support of sending Propositions 133, 134, 135, 136, 137, 138, 311, 312, 313, 314, and 315 to the ballot. Included is the "Secure the Border Act" (314), which would provide law enforcement the authority to arrest illegal border crossers to keep our communities safe after the Governor vetoed our original bills to address the crisis. Also, the "Children Are Not For Sale" measure (313) would protect children from sex trafficking by deterring this evil practice with a life imprisonment sentence for the offenders. INCOMPETENCE UNDERMINES ELECTION INTEGRITY

We told you last month about a lawsuit Senate Republicans joined to protect 97,000 Arizona voters from being deprived the right to cast a ballot in state and local races due to a government error, dating back more than two decades, where proof of citizenship was not documented. Most of these voters have routinely participated in our elections and are likely U.S. citizens. Even our own Senate President is on the list. Despite Maricopa County's efforts to block these voters from participating, a judge ruled they should be allowed to cast a ballot. Recently, media reported a leaked phone conversation where Hobbs shockingly suggested disenfranchising these voters. After the court ruling, the Secretary of State later revealed the number of voters impacted is actually 218,000! This is unheard of! The incompetence of those in charge of administering elections in Arizona in accordance with

INVESTIGATING TRAGIC FAILURES FROM DCS

Another failure from the Hobbs Administration tragically cost the life of an Arizona child in Department of Child Safety (DCS) custody, 15-yearold Christian Williams. At the very basic level, we're talking about keeping kids alive, and when you boil it down to that base level, it should anger every single Arizonan that DCS is unable to do that. Christian is the second child with Type 1 Diabetes to die in DCS care in less than two years. These children were allowed to refuse the insulin needed to keep them alive, which ultimately led to their deaths. Why?! This unacceptable incident shines a spotlight on the lack of accountability and transparency from the individuals Governor Hobbs picked to run our state agencies. Arizona Senate Republicans will not let these tragic deaths be in vain. FAKE DIRECTOR FALLOUT UNDER HOBBS

The latest tragedy at DCS doesn't even begin to scratch the surface of the fallout from Hobbs' fake director scheme, where she unlawfully evaded the Senate confirmation process for state agency director nominations by installing individuals for these critical roles under a made-up title. A report released by the Auditor General this month reveals a major \$2 million fraudulent transfer of taxpayer dollars from the Arizona Department of Housing, under the leadership of a Hobbs-appointed director who was rejected last year by the Senate Committee on Director Nominations for repeated cases of plagiarism. According to the report, the agency did not put in place procedures to prevent fraud, and the crime wasn't even discovered by the agency until six months after the fact. This is yet another prime example of why the Senate will not rubberstamp her director picks. Thorough vetting is crucial for the citizens of Arizona. -Senator Jake Hoffman

INFLATION MISERY UNDER HARRIS-BIDEN ADMIN.

STOPPING COSTLY ELECTRIC VEHICLE MANDATES Legislative Republicans are challenging the legality of the massive federal government overreach demonstrated by the Harris-Biden Administration's Environmental Protection Agency (EPA), after it overstepped its authority and costly electric-vehicle issuing radical mandates without Congressional approval. We joined a coalition of states and industries in filing an opening brief for a lawsuit this month to stop these recently adopted rules by the EPA as part of Biden's climate change agenda.
