INFLATION CONTINUES TO HURT ARIZONA FAMILIES Crippling prices on basic necessities continue to wreak havoc on hardworking Arizonans. Sadly, this will remain the case while the Biden Administration continues to enact costly policies, and while Washington D.C. continues its out of control spending spree. According to a recent report from the Common Sense Institute, the average family would have saved approximately \$8,400 annually over the past three years, if inflation remained at the Federal Reserve's 2% goal. federal lawsuit, Mexico is trying to blame American gun manufacturers for cartel violence, instead of their own government's negligent policies. California and other blue states, along with anti-gun activists, are working to support Mexico's efforts in an attempt to put gun manufacturers out of business. We recently joined 26 states to urge the U.S. Supreme Court to weigh in on this case. A foreign nation has no business using our court system to try to limit the rights of our citizens, yet that's exactly what's occurring with this \$10 billion lawsuit. The bipartisan Protection of Lawful Commerce in Arms Act (PLCAA) prohibits civil liability actions from being brought against manufacturers for damages resulting from the misuse of their products. It was enacted nearly a decade ago for a reason. The fact that this case was revived after being previously dismissed is a threat to our Second Amendment rights, and has the potential to set a dangerous precedent moving



forward, which is why we're fighting for the highest court to weigh in. -Senator Frank Carroll

BILLS SIGNED THIS WEEK
As a member of Senate Republican leadership, I'm proud of the work we've accomplished so far this session, and the impactful legislation we've worked to get signed into law. This week, we had four more Senate bills signed by the Governor, including two that will protect Arizonans against the nefarious aspects of artificial intelligence (AI) media technology, as well as create meaningful change within our seriously mentally ill (SMI) healthcare system. SB 1359, sponsored by Senator Carroll, will require a person who distributes a deceptive and fraudulent deepfake of a political candidate within 90 days before an election to include a clear disclosure that the media includes content generated by Al. SB 1609, sponsored by Senator Wadsack, simply requires a health care institution treating an SMI patient to provide an accurate list of all necessary medications when they're discharged. Both of these measures garnered bipartisan support and will take effect 90 days after we adjourn. -Senator T.J. Shope
